Nominee Eligibility Requirements

- Must currently provide direct services to a student (or students) with exceptionalities
- The work of the nominee must be consistent with CEC's mission statement as described in the first paragraph

Rules & Instructions for Nomination

1. Nominees may be nominated by an individual (principal, CEC member, fellow teacher/colleague, student, parent, self), educational organization (school, parent group, etc.), or community group. The nomination form should be completed by the nominee and must be signed by the nominee.
2. Letters of recommendation from nominator and building administrator of the nominee's excellence in providing special education services must be attached.
3. The nominator should complete the nomination form and send 3 copies of packet to:
